## About Highline Water District

Our mission is to provide high quality water and excellent customer service while effectively managing District infrastructure for a reliable water system today and for future generations.

Highline Water District serves potable water to approximately 110,000 people living and working in South King County—including portions of the cities of Burien, Des Moines, Federal Way, Kent, Normandy Park, SeaTac, and Tukwila, as well as areas in unincorporated King County. The District encompasses roughly 18 square miles and provides water to our customers through approximately 18,900 water meters. Seventy-five percent (75%) of our water is supplied by Seattle Public Utilities, with the remaining portion produced from three District-owned groundwater wells with two treatment facilities. The District employs 34 dedicated professionals and is governed by a five-member Board of Commissioners who are elected by the customers we serve. Our 2024 Operating Budget is \$21 million dollars and includes approximately \$8 million in capital improvements.

## About the Position(s)

The District has an opportunity for a Utility Worker or Senior Utility Worker in our Field Operations Department. Position placement and pay step is dependent on qualifications and experience.

**Utility Worker \$32.20 to \$41.86 per hour**

**Senior Utility Worker \$38.48 to \$50.00 per hour**

Incumbents in the Utility Worker position assist in the operation and maintenance functions of the District's water distribution system. They perform a variety of physically demanding work and use equipment, vehicles, and tools in all weather conditions to maintain or repair the system. Responsibilities include various maintenance program(s) related to the water system, District facilities, and vehicles.

The Utility Worker is generally considered an entry level position. Construction experience, CDL, or demonstrated mechanical aptitude is desired. Senior Utility worker requires 5+ years of experience, Water Distribution 2, CDL, or an applicable combination of education, training, and experience. The position requires residence within 25 miles of the District Headquarters.
