**RESOLUTION AUTHORIZING AN AMENDMENT TO HIGHLINE WATER DISTRICT
CODE SECTION 6.04.020, TABLE III – WATER/MISCELLANEOUS RATES**

WHEREAS, the Board of Commissioners and management have determined that it is necessary to adjust the rates for meter hangs to compensate for increased costs to the District.

WHEREAS, the District will purchase meters that are more accurate and efficient to reduce unaccounted for water loss.

WHEREAS, the District's current rate structure is as follows:

Fire Hydrant Installation Deposit - \$5,000				
When hydrant installation costs fall between \$4,800 and \$5,200, no refund or bill is generated. However, when the installation costs exceed \$5,200, the District will bill the customer for the overage of the deposit amount; when the installation costs are below \$4,800, the District authorizes a refund to the customer of the difference between the deposit and actual amount. 

NOW THEREFORE BE IT RESOLVED:


