1. CALL TO ORDER

President Guite called the meeting to order at 9:00 a.m.

2. APPROVE AGENDA

Commissioner Landon's motion to approve the Agenda as presented was seconded by Commissioner Johnson seconded the motion. The motion carried unanimously.

3. RESOLUTIONS/MOTIONS

Resolution <u>11-5-24A</u> accepting developer extension as complete (O'Reilly Auto Parts). Commissioner Johnson's motion to approve seconded by Commissioner Landon. After discussion, the motion carried unanimously.

4. STORAGE SYSTEM UPDATE

Debbie reviewed the proposal from Washington State Correctional Industries and informed the Commissioners that the system will hold up to 847 boxes and will be adequate for the District's storage needs. The system will be delivered in approximately six weeks and will take two days to install. The storage system is within the approved budget allotted for this purchase.

5. JOHNSON CONTROLS, INC. (JCI) SECURITY IMPROVEMENTS

Jeremy discussed the status of the security improvements for the McMicken Heights Treatment Plant with the Board. JCI, the District's security integrator, will design, provide consulting services, and purchase the security equipment for the McMicken Heights Treatment Plant as a sole source purchase of these special facilities as allowed by RCW 39.04.280. The District will discuss a change order with McClure and Sons, Inc., (General Contractor for the treatment plant) for the installation of the security improvements. District staff confirmed with the District's legal counsel the applicability of the statute.
