- Matt informed the Board that he plans to enter into a contract with Tom Keown via GHD, Inc. for consulting services on the District's ongoing projects until the Engineering/Operations Manager position is filled.
- Matt distributed a copy of the draft letter prepared on behalf of the Board to Maury Hood, President, WASWD Board of Directors, stating the negative position of Highline's Board regarding the proposed assumption legislation allowing a City Utility Tax. The Board reviewed the letter and unanimously agreed to sign the letter.
- Matt invited the Board to Tom's going away luncheon at the District on 1/8/08 at noon.

 <u>Project 05-4 Military Rd S.</u> – District is waiting on as-builts and the final bill from the City of Seatac.

<u>Project 06-1 Southcenter Parkway Extension</u> – The City of Tukwila and Segale are still in negotiations.

<u>Project 07-1 490 Zone</u> – The District will advertise for bids in the Seattle Daily Journal of Commerce on 1/28/09 and 2/4/09.

<u>Project 07-2 McMicken Heights Groundwater Treatment Facility</u> – Matt, Tom and Mike Becker are working with RH2 Engineering to reduce construction costs, however, this has increased the scope of RH2's consulting contract with the District resulting in a contract revision of approximately \$68,000. Matt and Mike will meet with the City of Seatac next Monday (1/12/09) to discuss a potential land swap.

<u>Project 08-1 Salt Air Hills</u> – Bid opening will be held at Midway Sewer District (lead agency) on January 22, 2008.
