4. RESOLUTIONS / MOTIONS

Resolution 09-5-6A authorizing amendment to Comprehensive Plan to allow extension to the water district system (Kealy Mini Storage). Commissioner Koester's motion to approve was seconded by Commissioner Landon. After discussion the motion carried unanimously.

Resolution 09-5-6B authorizing amendment to the Comprehensive Plan to allow extension to the water district system (McMicken Heights Elementary School). Commissioner Koester's motion to approve was seconded by Commissioner Landon. After discussion the motion carried unanimously.

Resolution 09-5-6C authorizing the General Manager to enter into an agreement for Mutual Aid and Assistance for Washington State for Intrastate Water/Wastewater Agency Response Network (WARN). Commissioner Koester's motion to approve was seconded by Commissioner Quong-Vermeire. After discussion the motion carried unanimously.

- Matt reminded the Board that the public hearing regarding the Des Moines Ordinance 09-022 for a proposed Pavement Mitigation Fee was scheduled for May 14, 2009 at the Des Moines City Hall. Matt, Jeremy and the Commissioner plan to attend the meeting.
- Matt commented on the article in the Kent Reporter entitled *Kent Council OKs major hike to residential water bills*. The City of Kent will increase by 48%, their residential water bills to help the City pay for the operation, maintenance, replacement and expansion of the water system as required by federal and state regulations for fire codes and health standards.

Matt informed the Board that the Des Moines City Council approved a motion on 4/2/09 to start assumption proceedings of King County Water District 54.

There being no further business of the District, Commissioner Johnson adjourned the meeting at 9:39 AM.


