- 7.1 Project 12-1 Military Rd S (S 176th St to S 166th St) The contractor will have all water main installed by the end of next week. Installation of services will follow. The District is waiting for the cost proposal from the contractor to remove a portion of the existing A.C. water main where it conflicts with proposed storm. A change order will be presented to the Board at a future meeting.
- 7.2 <u>Project 13-1A & B Angle Lake Water Main Replacement</u> The majority of legal descriptions for required easements have been prepared. BHC Consultants will continue meeting with property owners to obtain signatures.
