- 6.1 <u>King County ROW Rental Fee Litigation</u> Matt and Jeremy attended the hearing last Friday (7/27/18). The District is opposed to a rental fee for infrastructure located in the right-ofway of unincorporated King County. A decision is expected to be made by the judge at 3:30 pm today.
- Janus v. American Federation of State, County, and Municipal Employees (AFSCME) On 6/26/18, the Supreme Court found that requiring workers to pay a "fair share" to unions with which they politically disagree violates their freedom of speech. The District will have Archbright revise the labor contract with the United Association of Plumbers & Pipefitters (Local 32) to be in compliance with the new law.
