# 6. STAFF/COMMISSIONERS/ATTORNEY John Milne/Eric Frimodt, Inslee Best

6.1 <u>King County Right-of-Way Rent Ordinance</u>. Frimodt reported that King County had filed its appellate brief with the Supreme Court and that the district-defendants had until May 15, 2019, to file a responsive brief. The Supreme Court will then determine whether to grant direct review, or remand King County's appeal to the Court of Appeals for consideration. He will keep District staff further informed.

<u>Burien Franchise</u>. Frimodt and District staff reported on the status of negotiations with City of Burien staff on a City franchise, including the payment of a franchise fee similar to the franchise fees the District currently pays to other cities in which the District serves. Frimodt represents a group of six water-sewer districts, including the District, in the negotiations. He will keep District staff further informed.

<u>Federal Way Excise Tax.</u> Milne reported on the status of the District's appeal of the trial court's determination that the City's excise tax on the District's gross income was lawful. He and Phil Talmadge represented the District, Midway Sewer District, and Lakehaven Water and Sewer District in the matter. He reported the districts' appellate brief would be filed with the Supreme Court this week, and then the City would have thirty days to file a responsive brief, unless the City requested more time to file its brief. The Supreme Court will then determine whether to grant direct review, or remand the appeal to the Court of Appeals for consideration. He will keep District staff further informed.

6.2 <u>SR 509 Project</u> - HWD needs a temporary easement from the Best Western Hotel at 208<sup>th</sup> and International Blvd.

<u>Sound Transit</u>— HWD received an offer for the easements. Offer included a deduction for remediation of lead and arsenic in the soil. Staff requested a proposal from Shannon and Wilson to do an independent study of the contamination for the remainder of the site. Staff will bring resolution to a future Board meeting.

Sound Transit also issued a letter indicating their final offer for the office property easement or they will proceed with condemnation. HWD requested an additional 30 days for legal review and recommendations. Staff will discuss with the Board when additional evaluation is complete.

<u>City of Tukwila/Highline Water District Intertie</u> – HWD staff met with Tukwila's Public Works Director in accordance with the Interlocal Agreement to discuss repayment options. The City contends they didn't want the water or benefit from its use; therefore, they should not have to compensate the District. Tukwila will approach SPU to see if HWD could receive a credit and count the volume toward CWA's block contract. Discussion ensued. No action taken.
