RESOLUTION 19-11-20A

RESOLUTION ACCEPTING AS COMPLETE CONTRACT #18-70-21 WITH PUMPTech, INC. FOR PROJECT 18-4 McMICKEN WELL PUMP & MOTOR REPLACEMENT

WHEREAS, the District retained the services of Pump Tech, Inc., to remove and diagnose the Well pump condition under Contract #17-50-31 to determine the cause of the decline in Well production; and

WHEREAS, during removal of the equipment by Pump Tech, the well column separated causing the Well pump, motor and other equipment to drop within the well resulting in significant damage to the equipment. Pump Tech recovered the equipment and discovered the equipment was damaged beyond repair; and

WHEREAS, the District Board of Commissioners then authorized Project 18-4 McMicken Well Repair, to diagnose and replace the equipment under the 2018 Capital Improvement Program; and

WHEREAS, by passage of Resolution 18-7-18D, the Board of Commissioners waived competitive bidding requirements of RCW 57.08.050 for purchasing equipment involving special facilities and market conditions relating to Project 18-4 McMicken Well Repair and authorized the General Manager to purchase the replacement equipment at the McMicken Well; and

WHEREAS, the District entered into Contract #18-70-21 with Pump Tech, Inc. to replace and reinstall the Equipment; and

WHEREAS, the District's contractor, PumpTech, Inc., completed the construction of this project per District standards on 8/7/19 and the District Engineer recommends final acceptance. The General concurs; and

WHEREAS, the final construction amount was \$250,529.40 including W.S.S.T. (Exhibit A - Final Pay Request No. 1, attached and incorporated herein).

NOW, THEREFORE, BE IT RESOLVED:

1. The Board of Commissioners accepts as complete, construction contract #18-70-21 with PumpTech, Inc. for Project 18-4 McMicken Well Pump & Motor Replacement.
2. The General Manager or designee is authorized to sign the necessary paperwork to close out this project.


