6. STAFF/COMMISSIONERS/ATTORNEY Jeremy Delmar

- 6.1 <u>Florida Water Plant Cyber-Attack</u> Jeremy discussed the recent cyber-attack in Florida and gaps in their security system that allowed a hacker to remotely access the SCADA system and change the level of sodium hydroxide (lye) in the water.
- 6.2 <u>Risk and Resilience Assessment</u> The vulnerability assessment passed and Carollo Engineers is now working on the Emergency Response Plan Update to comply with America's Water Infrastructure Act of 2018.
- 6.3 <u>Project 21-1 24th Ave S Water Main Replacement</u> The City of Des Moines has plans for road improvements, installation of sidewalks and storm improvements on 24th Ave S from S 223rd St to Kent-Des Moines Road. The District's 10" AC water main conflicts with the proposed road improvements. Staff will present a resolution at a future Board meeting to authorize a contract with Parametrix to design the water main work.
