RESOLUTION AUTHORIZING THE CITY OF NORMANDY PARK TO PERFORM RESORATION SERVICES ON BEHALF OF THE DISTRICT ON SW 191ST ST

WHEREAS, City of Normandy Park informed the District of their plans to overlay SW 191st St west of 4th Ave SW and directed the District to make any necessary utility upgrades prior to their overlay work; and,

WHEREAS, the District performed improvements to the water infrastructure within the City's project limits and is responsible to trench patch the road prior to the overlay; and,

WHEREAS, the District uses their asphalt and concrete restoration contractor to perform trench patch work and is typically complete within 30 days after notice to proceed; and,

WHEREAS, the City, as part of the City work, is replacing curbs and performing other patching work along the project corridor that is not the responsibility of the District; and,

WHEREAS, all restoration work must be timely complete before the overlay this summer; and,

WHEREAS, the City requested the District authorize the City to perform the restoration work that is the responsibility of the District to reduce potential risk, inconvenience to the public, and prevent unnecessary delays to the City project; and

WHEREAS, the Franchise Agreement between the City and District authorizes the City to restore the right-of-way on behalf of the District, with the District to pay all reasonable costs; and

WHEREAS, the City has proposed to complete the District's restoration work and has provided a budgetary estimate in the amount of \$46,500, which the District has reviewed and found to be fair and reasonable.

NOW, THEREFORE, BE IT RESOLVED:

- The Board of Commissioners authorizes the City of Normandy Park to complete the pavement restoration work for which the District is responsible on SW 191st St, and the District will reimburse the City for these direct costs.
- The General Manager or designee is authorized to execute any necessary paperwork on behalf of the District to have the work performed.

ITEM 4: Site 1 - Pavement Repair Revisions at SW 191st Street

The Contractor is directed to shift the sawcut for the pavement patch on the north side of SW 191st Street to the south side of the existing temporary patch from the recent water district trench work. Construct an additional 6.5-foot wide pavement patch along the new sawcut in this area. The 6.5 foot wide patch is to include 4 inches of HMA over the existing subbase. The added 6.5 foot wide patch is directly to the south of the 2-foot wide pavement patch that is shown to be placed along the gutter line per detail 3 on sheet TS-1. Payment for the additional pavement removal, excavation below the pavement and disposal will be paid via bid item 11 Removal of Asphalt conc. Payment — Site 7. Payment for the additional commercial HMA will be paid via bid item 15 as noted below.

COMMENTS:

Highline Water District completed the replacement of a 6" AC water main under SW 191st St ahead of a City of Normandy Park overlay project. Prior to the overlay, the city is also replacing curbs on SW 191st St. Both the city and the District need to complete pavement restoration before the pavement overlay is applied this summer.

The Franchise Agreement between the District and the City includes a provision allowing the City, to restore the right-of-way on behalf of the District, with the District covering all reasonable costs.

Normandy Park has approached the District with a proposal to use their contractor for all restoration work. The city has provided an estimate for their contractor's services totaling \$46,500. The District has reviewed and found it to be fair and reasonable.
