WHEREAS, the President of the United States issued Disaster Declaration #FEMA-4775-DR-WA for severe winter storms, straight-line winds, flooding, landslides, and mudslides in Washington State, including King County, on April 28th, 2024, for the period of January 5th through January 29th, 2024; and,

WHEREAS, the Disaster Declaration provides funds to subrecipients for emergency work and the repair or replacement of disaster-damaged facilities, as approved by FEMA; and,

WHEREAS, the District performed emergency work and repairs between January 5th and January 29th, 2024, related to the winter weather; and,

WHEREAS, the District's highest elected official or highest authorizing authority must designate an Applicant Agent and Alternate Agent to execute contracts, statement of documentation, final inspection reports, A-19 Vouchers, time extensions, or other documentation pertaining to the grant and reimbursement.

NOW, THEREFORE, BE IT RESOLVED,

- 1. The President of the Board of Commissioners is authorized to execute the "Designated Applicant Agent" Letter (Exhibit A), specifying the General Manager as the designated Applicant Agent and the Operations Manager as the Alternate Applicant Agent.
- 2. The General Manager or designee is authorized to apply for and receive funds for emergency work and repairs pertaining to the Disaster Declaration FEMA-4775-DR-WA on behalf of the District.
